INDICATIVE ANNOUNCEMENT

The Company and all members of the Board of Directors warrant that the information disclosed herein are true, accurate, complete and without any false contents, misrepresentations or material omissions.

On 28 November 2008, Weichai Power Co., Ltd. (the “Company”) received from the Patent Re-examination Board of the State Intellectual Property Office of the People’s Republic of China (“CPO”)(中華人民共和國國家知識產權局專利複審委員會) the Notification of Termination of Examination on Request for Invalidation (《無效宣告案件結案通知書》), in which it set out that China National Heavy Duty Truck Group Co., Ltd. (“CNHTC”) submitted a written statement to CPO on 13 November 2008 to withdraw its request for invalidating the patents owned by the Company, including ZL200320121039.6 (Diesel Engine Oil & Gas Separator (柴油機油氣分離器)), ZL200320121422.1 (Front Diesel Engine Crank Sealed-Up Device (柴油機曲軸前油封密封裝置)), ZL200520124550.0 (flange of Spiral Trough Structure (螺旋槽結構的曲軸法蘭)) and ZL200520125023.1 (First Camshaft “Tool Set” Used In Diesel Engine (用於柴油機的第一凸輪軸襯套)). In accordance with Article 71 of The Implementing Regulations of the Patent Law of the People’s Republic of China (《中華人民共和國專利法實施細則》), the case of CNHTC appealing to CPO for the invalidation of the above patents owned by the Company on 6 November 2007 was terminated, with the Company legally and legitimately owning the above patents as the final result.
